Vender Space Information

Booth fees are \$20 per vendor and waived for non-profit organizations. Vendors that need power will be charged an additional \$5. Vendor areas will be split up into 4 locations around the square - food, arts/crafts, childrens play area and informational/ non-profit organizations. Vendors are allowed to set up on a first come basis upon arrival in designated areas. Vendors are responsible for tables, chairs, electrical cords or any ammintities you will need during the event. We request ALL vendors stay open until 9:00 P.M. No Vehicles will be allowed on the square till after 9:00P.M. Food vendors are responsible for check-ing with the Talladega Health Department (1004 South Street E, Talladega, AL (256) 362-2593) for inspections and forms. The April on the Square committee reserves the right to reject any material it deems unsuitable. Vendors are responsible to comply with the State of Alabama tax regulations. April on the Square is non-profit organization, so your participation goes back into the community.
